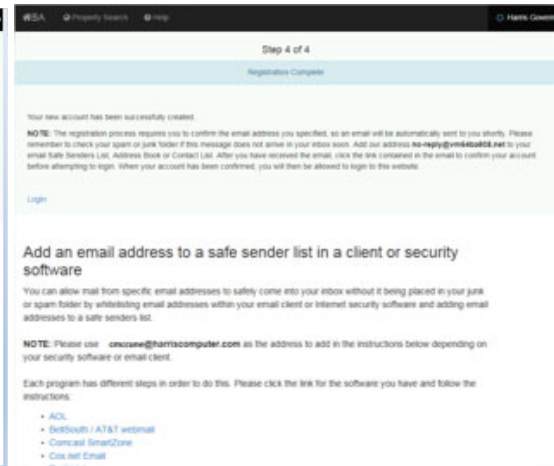
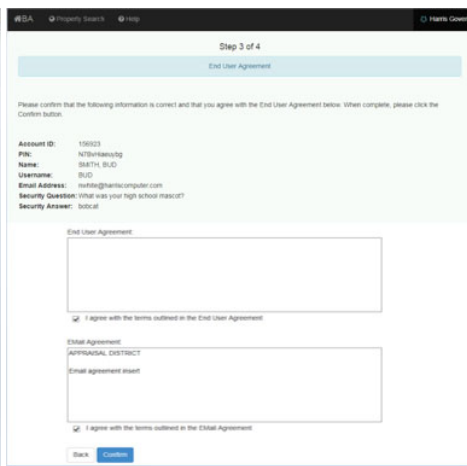
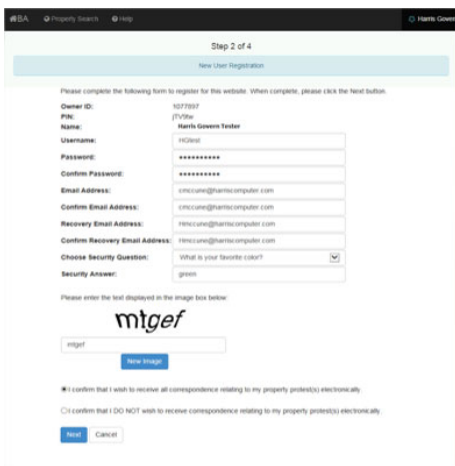
Online Access

- The registration process [Create New User] is the same for Taxpayers and Agents.

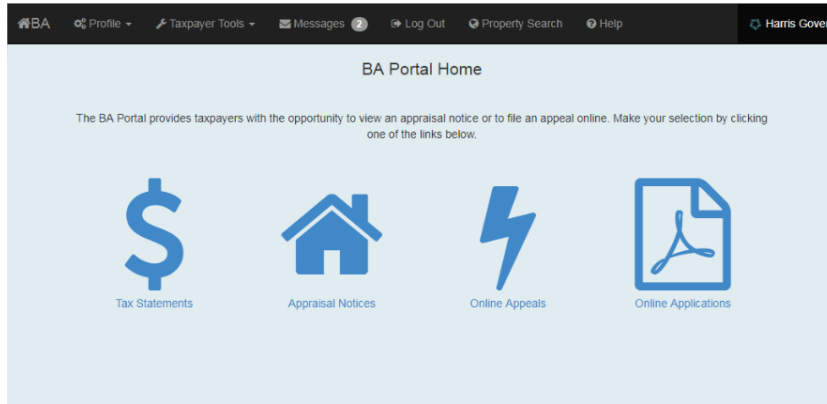


NOTE: The registration process prompts for 'Account ID' which is either the Owner ID or Agent ID.
